## Gift Aid - increase the value of your subscription without paying a penny more

- Making a Gift Aid declaration is an easy way of allowing the National Trust to reclaim the tax you have already paid.
- Your membership subscriptions and/or donations are worth a quarter more, for example for every £10 you give us we can reclaim £2.50 from HM Revenue and Customs.
- Anyone who is a UK income, or capital gains taxpayer can make a Gift Aid declaration.
- Over 2 million of our members have already made a Gift Aid declaration.
- One Gift Aid declaration will cover all your future donations and membership subscriptions.\*
- You can cancel your Gift Aid declaration at any time simply by contacting our Supporter Services Centre on 0844 800 1895.
- To maximise your tax giving, your Gift Aid declaration will be automatically backdated 4 years, as permitted by the Gift Aid Scheme. If you have begun paying taxes more recently, or would prefer not to backdate the declaration for any other reason, please call us on Tel: 0844 800 1895; Minicom: 0844 800 4410.
- Gift Aid is not a method of payment so you still pay your subscription by Direct Debit or cheque in the usual way.

\*Please note that we cannot reclaim tax on Individual Life membership or Individual Pensioner Life membership subscriptions.
